DIRECTIONS

From The Yuma International Airport

- Proceed straight from parking lot onto Pacific Ave.
- Turn **RIGHT** onto 16th St. /US-95. Proceed approximately 20 miles.
- Turn **LEFT** at the big guns onto Imperial Dam Rd.
- If you do not possess a military or Common Access Card, proceed approximately 1 mile, and turn left at the Visitor Control Center (VCC) to obtain a visitors pass. Our Event Access List will be at the VCC. Just let the guard know that you on “on the list for the Cyber & IT Expo”.
- From the VCC, travel approximately 4.5 miles on Imperial Dam Rd and turn right to enter Gate 2 (Howard Gate); the YPG Cantonment Area.
- Once on post, follow C Street through the gate, turn right on Second Street, then right on F Street.
- There is covered parking on the northwest side of the Fitness Center (visible from the street) as well as parking stalls on the street in front of the Fitness Center and the adjacent swimming pool facility.

Ample open parking is available at the YPG Fitness Center. There is covered parking on the northwest side of the Fitness Center (visible from the street) as well as parking stalls on the street in front of the Fitness Center and the adjacent swimming pool facility.

Public transportation such as Ubers or Taxis will not be allowed to access Yuma Proving Ground.
