Please plan on staying in downtown Anchorage and making the drive out to JBER on the morning of the event. JBER is approximately a 20-minute drive from downtown Anchorage.



DIRECTIONS TO JBER

From downtown Anchorage to JBER: (approximately 20 minutes).

- Take the N Glenn Highway towards JBER.
- Next take the Boniface Pkwy Exit towards JBER – Mt View Dr.
- Turn left onto Boniface Pkwy once you exit.

- You **DO NOT** have to stop at the Visitors Center. Proceed directly to the gate. Be prepared to show your Real ID Driver's License to the gate guard. Reference the "Event Access List (EAL) for the AFCEA Alaska Cyber & IT Forum at the Arctic Warrior Events Center".
- Once on base drive through the gate and continue on Vandenburg Avenue in the left lane. **Veer left on Vandenburg Avenue at the 2nd stop light after you enter base.** (Vandenburg Ave forks at the light and you will see a sign pointing left for the Arctic Warrior Events Center (AWEC).
- When you pass the traffic light you will be on Arctic Warrior Drive.
- Follow Arctic Warrior Drive past the Burger King and prepare to make a right-hand turn onto 18th Street. Make the right-hand turn on 18th Street.
- Follow 18th Street all the way until you see the Arctic Warrior Events Center (AWEC) on you left hand side just before you reach Kuter Avenue.
- **See the map below for the general route to the AWEC from the Boniface Gate.**



PARKING & PUBLIC TRANSPORTATION

Ample open parking is available at Arctic Warrior Events Center (AWEC). Public transportation such as Ubers, or Taxis, will not be allowed to access JBER
